



Membership Application

Thank you for your interest in becoming a volunteer member of the Reamstown Fire Company No.1. The Reamstown Fire Company No.1 provides Fire and EMS services for portions of East Cocalico and Ephrata Townships. Any person age 14 and older is eligible to apply. In order to become a member this application must be completed in its entirety and a non-refundable fee of \$10 (payable by cash or money order) must be included with the application.

After the completed application and fee have been received applicants will enter into a probationary period. The probationary period will last for three (3) months, during which time the application will be reviewed by the membership committee. During this time the applicant will need to complete background checks which are required by law. Instructions will be provided to the applicant once the application has been received. Any fees incurred while conducting the background check(s) will be the responsibility of the applicant. The background check(s) are required to be completed within the first 30 days of the probationary period in order to continue the application process. During the probationary period the applicants name will be read at each company meeting which occur on the first Monday of each month. When the applicants name is read at the third company meeting a vote will occur. This vote will determine if the applicant will be accepted into membership with the Reamstown Fire Company No.1. The applicant will be informed of the decision in writing within ten (10) days of the vote. Applicants who are accepted will receive a membership packet. After acceptance, members will be subject to a required annual membership fee to maintain their membership.
